- (a) Hong Leong Maruken Sdn Bhd, a 70% subsidiary;
- (b) Varinet Sdn Bhd, a 60% subsidiary;
- (c) Guotrade (Malaysia) Sdn Bhd, a wholly-owned subsidiary; and
- (d) MZ Engineering GmbH, an indirect wholly-owned subsidiary.

The liquidations are currently pending completion of legal execution proceedings against debtors and/or tax clearance from the Inland Revenue Board.

Subsequent to the quarter under review, Century Touch Sdn Bhd ("CT") (formerly known as Guocera Tile Industries (Labuan) Sdn Bhd), a 70% owned subsidiary of Guocera Holdings Sdn Bhd, which in turn is a wholly-owned subsidiary of the Company, has been placed under members' voluntary liquidation by its members pursuant to Section 254(1)(b) of the Companies Act, 1965. Mr. Ling Kam Hoong of Messrs Ling Kam Hoong & Co. has been appointed as liquidator of CT.

12. Contingent liabilities or contingent assets

There are no contingent liabilities or contingent assets as at the date of this report.

13. Review of Performance

For the quarter under review, the Group recorded a revenue of RM540.0 million and profit before taxation ("PBT") of RM58.0 million respectively compared with a revenue of RM402.1 million and PBT of RM49.5 million recorded in the corresponding quarter of the previous financial year ended 30 June 2011 ("FY 2011"). The aforesaid revenue and PBT were not inclusive of the results of Malaysian Pacific Industries Berhad ("MPI") which was disclosed separately under the caption "Discontinued Operations". MPI ceased to be a subsidiary of the Group at the end of FY 2011.

Included in the results of quarter under review were the results of the industrial products business which was acquired via the acquisition of the entire equity interest in Hume Industries (Malaysia) Sdn Bhd during the third quarter of FY 2011. The increase in revenue and PBT was partly contributed by the inclusion of the aforesaid industrial products business in the quarter under review.

14. Material changes in profit before taxation against the immediate preceding quarter

For the quarter under review, the Group recorded a PBT of RM58.0 million as compared with a PBT of RM61.3 million recorded in the preceding quarter. There were no material changes during the quarter under review.

15. Prospects

Barring any unforeseen circumstances, the Board expects the Group's performance to be satisfactory for the financial year ending 30 June 2012.
